- advocating for Nation-States to protect human rights defenders through the recognition and compliance with international instruments, and the passing of public policies

# Our Approach to the Protection of HRDs

#StandwithHRDs #DefendtheDefenders Right to defend human rights: We promote a rightsbased approach to the protection of HRDs, seeing them as subjects of rights, rather than objects of protection.

Collective protection: We promote collective strategies that strengthen the group and allow for more sustainable protection practices that go beyond individual security measures.

Protection networks: We promote the strengthening of internal and external solidarity networks among HRD groups and communities so that they are better positioned to confront threats and attacks.

Psycho-social approach: We understand that care and protection are indivisible. This means that protection strategies should address the individual and collective emotional impacts that HRDs experience as part of their struggles and processes, as well as integrate strategies for individual and collective well-being as a part of protection.

### Defenders

The right to defend human rights arises from the (non-binding) Declaration on Human Rights Defenders. The Declaration is mostly around the right to defend rights, and about doing it without being afraid of the consequences of it.

"Defenders" is not a "standard", plain category of actors... there is a diversity of defenders engaged in the defense of all human rights, in different contexts, facing different barriers and discrimination, and enjoying different levels of recognition and solidarity. In terms of defending defenders, there is no one-size-fits-all defenders due to the diversity of defenders and contexts



## Defending the Defenders

Defending the defenders: primary stakeholders, dutybearer stakeholders, key stakeholders.

Primary stakeholders: Defenders themselves have a primary stake around it. There are a number of interventions focusing on supporting defenders, contributing to building their capacities, etc. This is a necessary and crucial, but not sufficient line of action to contribute to defend defenders, especially when defenders confront resourceful, powerful actors.

**Duty-bearer stakeholders:** State and government authorities must protect defenders, and they are in many cases the only actors that actually can protect them, even if some of (or all) of these authorities are putting pressure or directly attacking defenders.

Key stakeholders: are targeted partners where we focus efforts for support and intervention such women human rights defenders, environmental justice defenders
